Funding supports the capacity of the network to warehouse, transport and distribute this food to the emergency food assistance network; identifying and supporting innovative programs to meet emerging needs and providing training and technical assistance to foodbanks, food pantries and soup kitchens.**

**The Ohio Benefit Bank (OBB) is a public-private partnership with the Governor's Office of Faith-based and Community Initiatives, Ohio Departments of Job and Family Services, Development, Aging, Corrections, Education and Health, in addition to two federal agencies, foundations and more than 1,000 community and faith-based organizations which links low and moderate income Ohioans to work support programs and tax credits to help improve their lives.**  
**The Ohio Association of Second Harvest Foodbanks serves as the lead agency that supports, host and administers this web based software service that breaks down barriers and helps simplify the application process for over 21 work support programs and tax credits.**

These outreach efforts reached 42,666 low-income Ohioans and helped educate over 20,280 Ohioans about the benefits of the Food Assistance Programs.**
